



Online Mapping System Subscription

The Online Mapping System provides users with rapid access to Ohio's cultural resource data in digital format. The site allows users to query cultural data and produce maps. We hope the use of this site promotes the utility of GIS and spatial data as decision-support tools for federal undertakings subject to Section 106 of the National Historic Preservation Act and for scholarly research on Ohio history, architecture and archaeology.

Subscription Fee

Access to the Online Mapping System is limited to paid subscribers. Funds from subscribers will help enable the site to be properly maintained and improved. In the first year, the subscription fee will be pro-rated as each quarter lapses.

These prices do not include sales tax, which is an additional 6.75%. The subscription period for partial-year subscriptions is determined by the account activation date. Should the subscriber wish to increase the active period once it is set for the year, the subscription must be increased to twelve months. The fiscal year for all accounts is the state fiscal year, July-to-June.

Print out and complete the following subscription form and mail it with payment to the Ohio Historic Preservation Office, 1982 Velma Avenue, Columbus, OH 43211-2497. Payment by check payable to the Ohio Historical Society or purchase order is preferred.

PDFs Available

PDFs of Ohio Historic Inventory, Ohio Archaeological Inventory and National Register forms identified within query areas can be provided for \$.50 per record-plus tax. PDF files will be emailed if they comprise less than 3MB; otherwise they will be burned to CD and mailed for an additional \$2.50 per CD. To order PDFs, please provide our office with a list or table of the specific site numbers requested. Orders can be placed via email sent to ohpo@ohiohistory.org or by calling the Ohio Historic Preservation Office at 614-298-2000. Requests for PDFs will be filled in the order received and will generally be filled within 5 business days. The Ohio Historic Preservation Office retains the right to turn down PDF requests.
